To call someone lily-livered is to directly challenge their bravery, decision-making, or ability to stand up for themselves or others. It may be heard in contexts where someone refuses to take a necessary risk, backs down from a confrontation, or consistently avoids difficult tasks.

The term is sometimes used in literature, films, or comedic contexts to exaggerate a character's fear or reluctance. It can add color to a description or bring out a humorous image of someone trembling or retreating at the first sign of trouble. However, in real-life conversation, it is less commonly used today and may sound outdated or overly dramatic unless used deliberately for effect.

Though largely archaic, "lily-livered" still finds its way into modern speech in satirical writing, parody, or historical dialogue. It has also evolved to represent not only physical cowardice but moral weakness, where a person lacks the conviction to stand up for what is right or speak out in difficult situations. It reflects a failure of courage not just in action but in principle.

The phrase can also reveal something about the speaker. Using such a colorful and harsh term may indicate frustration or disappointment with someone who has not lived up to expectations of bravery or strength. It implies a certain standard of behavior and criticizes those who fall short, whether justly or unfairly.

In conclusion, to be called lily-livered is to be accused of cowardice or weakness, both physically and morally. The term, though rooted in old beliefs and language, continues to carry weight as a sharp critique of those who lack the courage to face challenges. Its enduring power lies in its striking imagery and cultural history.
